### Personal data being processed and use of personal data

When you engage in certain activities on <a href="www.cp-lv.com">www.cp-lv.com</a> web page, such as applying for available job, delivering CV, making job enquiry via online form or downloaded Word document, sending us feedback, requiring information on our services, we may require certain additional personal data from you. - 12. Collected personal data are used exclusively for purposes stated in items 11 and 14 of these General Terms and Conditions.
- 13. Depending on types of activity, some data we require from you are designated as compulsory and some as voluntary. In case you do not provide the compulsory data for certain activity requesting it, you will not be allowed to engage in such activity.

Company Crystal Pool (Latvia) Ltd. collects and uses personal data in order to enable you the use of its services and activities via <a href="https://www.cp-lv.com">www.cp-lv.com</a> web page, to advance the operation of <a href="https://www.cp-lv.com">www.cp-lv.com</a> web page, to create a database of its users, for marketing



purposes, in order to contact you and to deliver marketing messages, to improve our advertisement and promotional efforts, to analyse the use of <a href="https://www.cp-lv.com">www.cp-lv.com</a> web page. Furthermore, we may use your personal data for solving problems, performing administrative tasks, to establish a contact with you.

### Submission of personal data

#### Other data

We use the analysis software for our web page analysis by which we analyse the use of web page and thus gain valuable knowledge on the needs of our users with the intention of improving the quality of our services. In relation to this, so called cookies are also being used. Cookies are textual files which are stored on the computer of the web page visitor. They allow the recognition of user upon revisiting the web page. This allows us to conduct above mentioned usage analysis. The mentioned software in addition to this also collects and stores some technical data, including IP address of the user. We emphasize that in no case there is identification of persons behind such data or the collection of personal data.
